The organization instituted an outside Express Line whereby clients are served monthly by driving through the Express Line and food is placed in their vehicles, minimizing the possibility of spreading the disease.

In addition, in June of 2020 we started Meals On A Mission, where food is delivered on a weekly basis to clients who don't have the ability to travel to Sweetwater Mission. This has expanded our ability to service more families.

We also started our Community Cares program, whereby we are able to distribute food to nonprofits that are not large enough to be part of the Atlanta Community Food Bank in addition to any Churches or non profits that need help with food.
